## **Raiffeisen Equity – leader by performance since the beginning of 2011**

According to Investfunds rankings (Cbonds group) for January 2011 investment fund Raiffeisen Equity has shown the best performance among open-ended funds – 7.9%. UX index has grown for 7.74% for the period indicated.

Investment fund Raiffeisen Equity – is an open diversified fund launched at the beginning of July 2010. Nominal value of investment certificate was 500 UAH. Current value is 565.11 UAH. Investment fund portfolio is 90% equities and 10% - fixed-income instruments.

“Due to the fact that top positions of the Fund’s portfolio are equities of sectors which were the best in 4-th quarter of 2010 and from the beginning of 2011 (oil and gaz, energy, machinery and commodities) the Fund has become the best at the market among open-ended mutual funds. Performance of Raiffeisen Equity is higher than benchmark (UX index) which one of the main indicators of effective investment fund activity”, - comments Vadym Mosiychuk, the CEO of Raiffeisen Aval Asset Management.
